Introduction

In an effort to improve the visibility of registration fees, licence fees and annual fees, the Financial Services Authority ("the Authority") has drafted this document consolidating all the relevant fees applicable for all products under its administration.

This document aims to provide a summary of the indicative fees in the relevant legislations, thus it is not intended to be comprehensive nor replace or override any legislative provisions. In the event of any discrepancy between the relevant legislations and this document, the former shall prevail.

Future reviews will be done to ensure the information provided within this document are up-to-date and accurate.

The submission of a licence application to the Authority must be accompanied by the relevant application fees and documents depending on the type of licence being sought.

The annual fees are to be paid to the Authority every year after licensing.

For companies licensed during the first quarter, the full licence fee will have to be paid. For companies licensed during the second quarter, 75% of the annual fee will be paid. For the third quarter a rate of 50% and for the fourth quarter a rate of 25% will have to be paid to the Authority.

^{*}Depending on the quarter in which an International Corporate Services Provider, International Trust Service Provider or Foundation Service Provider is licensed, the Authority will prescribe for a pro-rated fee to be paid as the annual licence fee. For clarification purposes, this annual licence fee will only be pro-rated for the first year of licensing.
