

INVITATION TO TENDER PROCUREMENT FOR CONSULTANCY SERVICES (PROJECT MANAGEMENT).

The Consultancy team/firm shall consist of an Architect, Structural and Civil Engineer, Quantity Surveyor (QS), Mechanical Electrical and Plumbing (MEP) Engineer.
