

INVITATION TO TENDER

Title: Refurbishment of Ceiling, Electrical Rewiring, Telephone and Network Recabling at the Financial Services Authority (FSA) Administration Building at Bois De Rose Avenue.

Source of Finance: Financial Services Authority.

<u>Eligibility:</u> The Following are eligible to tender on equal terms.

- 1. All Registered Contractors with a Valid Class 1 license operating in Seychelles.
- 2. Shall have the legal capacity to enter into a contract with the FSA.
- 3. Shall not have been suspended from participating in any tender in line with Section 94 of the Public Procurement Act 2008.

Conditions: At least 5 years' experience in construction works.

Place of Performance: Financial Services Authority Zone (Ex-SIBA) at Bois De Rose Avenue.

Performance Period: Three (3) Months.
